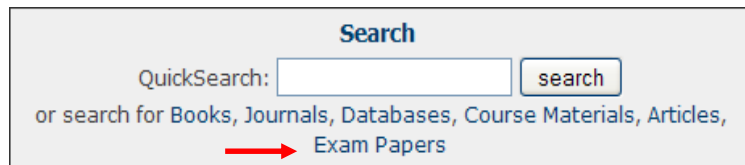
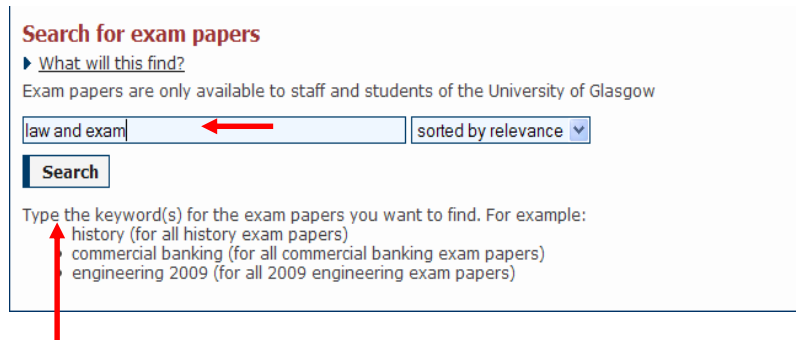


How do I find exam papers?

Finding exam papers is easy – click on the **Exam Paper** option under the QuickSearch box on the Library homepage



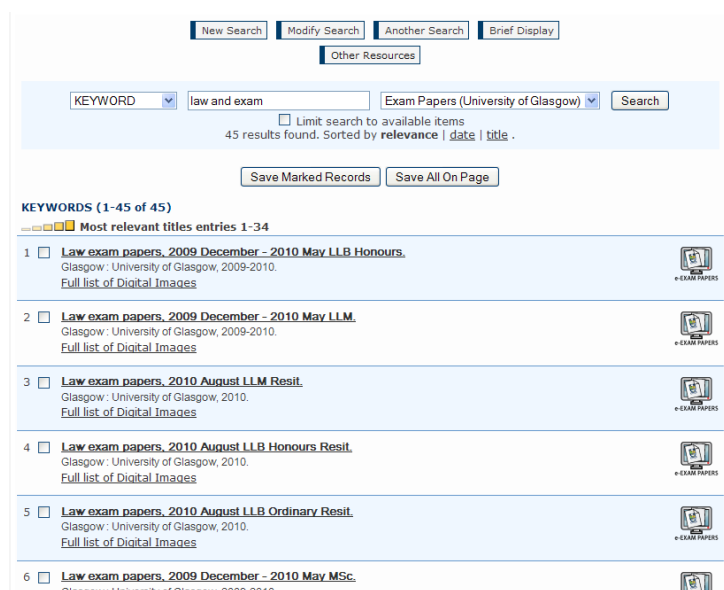
Simply enter the keywords of the exam paper you are looking for into the Search box. In this example, we are looking for a Law exam paper so I've entered Law and exam into the search box.



Click on the search button to continue

The results list shows all the Law exam papers available
You can scroll down the page to see all the years available.

You will see that exam papers for Ordinary, Honours and Masters courses are listed separately as are the Resit papers



To access the papers you can click on the title or on the “Full list of Digital Images” link
